1. What is this product about?

Letter of Credit Transfer (LCT) is a service that allows you (1st Beneficiary) to transfer in full or partial amount of the letter of credit to another supplier (2nd Beneficiary).

2. What do I get from this product?

- Enable you (Trader/Middleman) to control the trade transaction better and arrange similar terms in procuring the goods from the supplier/manufacturer to be delivered to the buyer.
- Allow you as the first beneficiary to change the invoice and draft if any, to meet the terms and conditions of the master LC to get payment.

3. What are my obligations?

- You are required to ensure that the terms and conditions of the master letter of credit can be complied with before
 request it to be transferred.
- You are required to pay our transferring commission.
